

# #AQFontour - 2022 edition



## Regulations:

1. The competition is organized by AQUAFORM Inc. Sp. z o.o., ul. Przemysłowa 12-14, 32-070 Czernichów, hereinafter referred to as AQForm or the Organizer.
2. The competition consists in taking and sending a photo presenting the latest AQForm 2022-2023 catalogue, located in an interesting interior, surroundings or outside with a single sentence description of the space in which the photo was taken.
3. Submitting a photo means agreeing for the publication thereof and shall not require signing additional licenses and consents to further use of the photos by AQForm.
4. The best photos will be published on AQForm social media.
5. Sending a photo is not tantamount to publishing it – we will only publish photos selected by the AQForm team, according to the team's discretion.
6. Published photos will be rewarded with a set of small gifts funded by AQForm.
7. Awards will be sent after the photo is published within 7 business days of receiving the delivery address. The Organizer is not responsible for any delays in delivery resulting from the actions of the deliverer.

9. A maximum of one submission can be submitted in a single message.
10. The author joins the competition by sending photos in JPG format with a resolution of 300 dpi and a shorter side with a minimum size of 2000 pixels.
11. The size of the e-mail should not exceed 15 MB. It is permissible to send links enabling to load projects from external servers (the so-called clouds).
12. The title of the message should clearly indicate the place where the photo was taken, i.e.: „#AQFontour\_place”

Participants in the competition may be natural persons of legal age with full capacity to perform acts in law, who are the author of the submitted photo or photos and who have copyrights to the photos submitted. The Organizer shall not be liable for Participant's violation of personal and property rights of third parties.
19. Sending a competition entry means that the participant:
  - a. takes part in the competition and accepts these regulations;
  - b. has full copyrights: personal and property rights to the submitted photos and can freely dispose of them;
  - c. grants Aquaform, free of charge, and for an indefinite period of time, a non-exclusive and territorially unlimited license to use photos or visualizations in the following fields of exploitation:
    - I. producing, recording and reproducing photos in whole or in part by any means, in any form, by any technique — including printing, reprography, magnetic recording and digital technology, including publishing in any way and in any form of a computer network, via the Internet, also on „websites“; this scope also includes reproduction and transmission for printing and marketing;
    - II. transferring for printing or displaying, storing, entering into computer memory, displaying;
    - III. public sharing, including sharing the photos through public exposing, displaying, and making them publicly available so that everyone can access them in a place and time they choose;
    - IV. the right to use for promotional purposes;
    - V. adaptation and format changes;
